But the circumstances in Hinckley's case, the prosecution, and the family's outrage in general have shifted the conversation to the broader availability and use of mental health treatment — especially for people with schizophrenia, the prevalent diagnosis in Hinckley's case. Hinckley's trial attorneys, B.J. Lally and E. Paul Tabler, taught criminal law at Suffolk University Law School for decades. Tabler died in 2012. In the early years of his career, Tabler said he met him in court on at least a dozen occasions and his client repeatedly refused to treat his schizophrenia. "He just couldn't understand that you shouldn't be creating a public disturbance if you are sick." Tabler said.
